
Invitation for Bids

 - Minimum Work experience of similar size and nature: at least one contract in last 10 years with value of **NRs. 4,42,00,000.**

6. Sealed or electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before **12:00, 01 November 2020** Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hour on 01 November 2020** at the office of **Thabang Rural Municipality, Thabang, Rolpa**

Bids must be valid for a period of **90 days** and must be accompanied by a scanned copy of the bid security as specified above in .pdf format for e-bid, which shall be valid for 120 days from the final bid submission date. If bidder wishes to submit the bid security in the form of cash the cash should be deposited in the bank account with the following information.
